

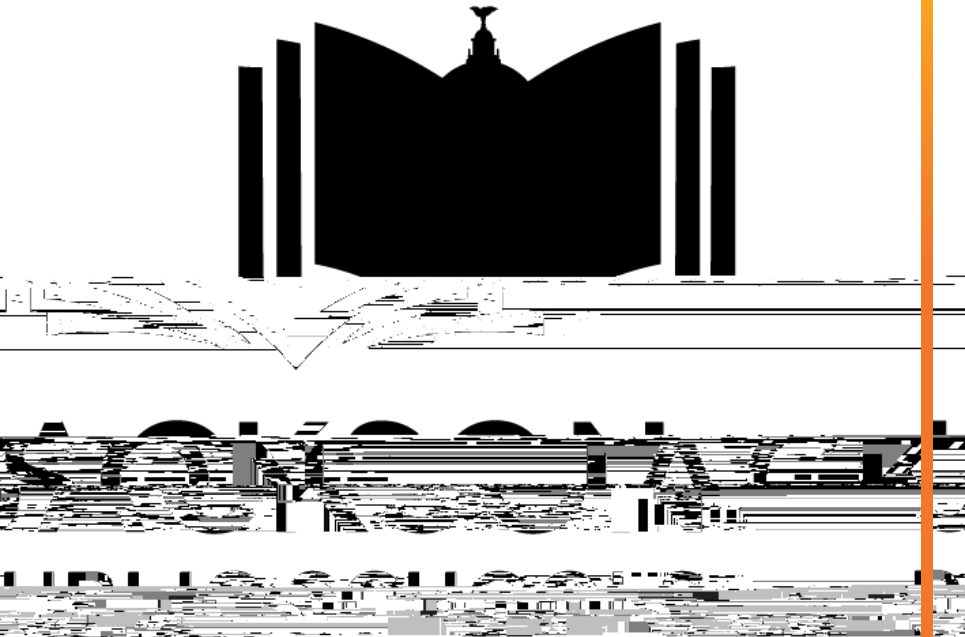

JPS Bond Construction Program

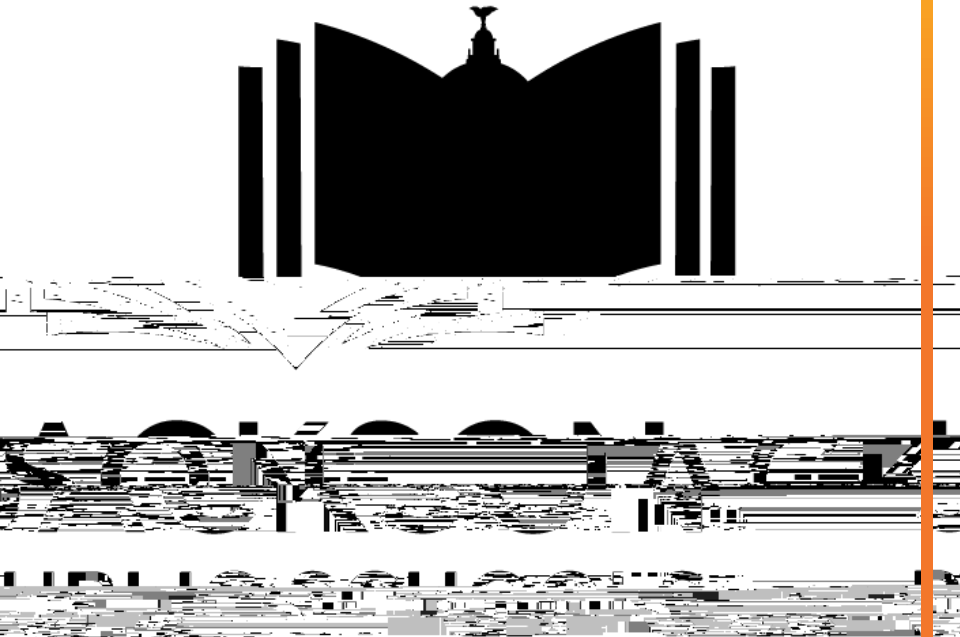
- **Date of Bond Vote:** August 7, 2018
- **Passage Percentage:** 86%
- **Amount of Bond:** \$65 Million

 - Final Completion

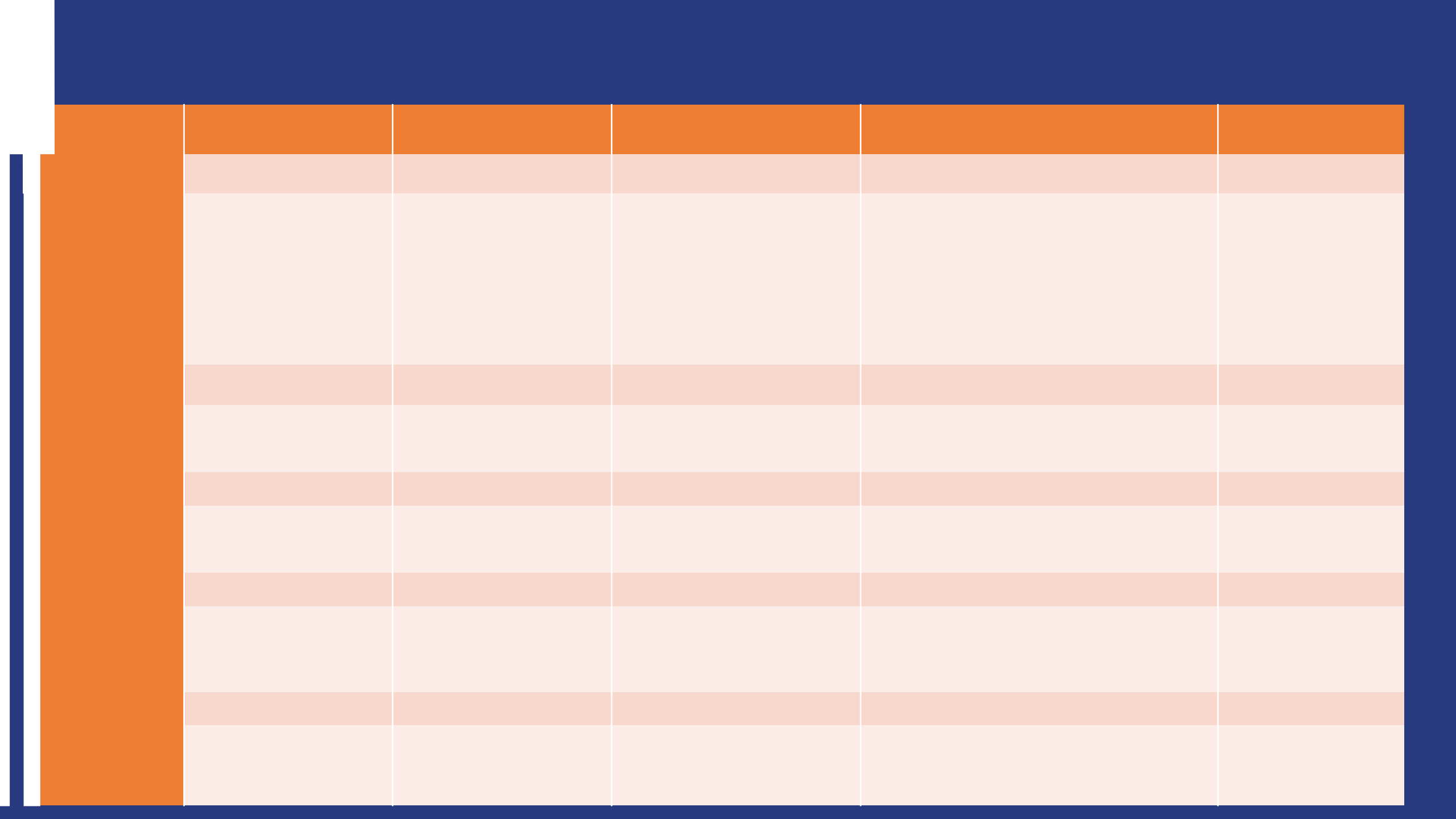

- Any modifications or renovations of a facility that is at least 50 years of age are required to be reviewed by (MDAH)
- 75% of JPS Schools are 50 years or older
- 9 schools have been designated as Landmarks
